Appendix L: Abbreviations in Resource Description & Access Records

Below are standard Latin alphabet abbreviations from "Appendix B" of *Resource Description & Access* (RDA). These abbreviations can be used in most MARC fields of the bibliographic record; e.g., the 020 ISBN, 5XX note. Transcribe series title and series captions in 490 fields as they appear on the work, but prefer Arabic numerals for the series number. Country and state abbreviations from the standard list below can be used in fields such as the 260 place of publication subfield a. Other relevant *RDA* abbreviation rules, such as for size dimensions and describing the extent of a work, follow the tables. We generally do not abbreviate when describing the extent of a work like a book in 300 subfield a.

B.11 Names of Certain Countries, States, Provinces, Territories, Etc. ICPCCPS

Use the abbreviations in **table B.1 RDA** for the names of certain countries and for the names of states, provinces, territories, etc., of Australia, Canada, and the United States when the names are recorded:

- a) as part of the name of a place located in that state, province, territory, etc. (see 16.2.2.9 RDA) or other jurisdiction (see 16.2.2.11 RDA)
- b) as the name or part of the name of a place associated with a person (see 9.8–9.11 RDA) family (see 10.5 RDA), or corporate body (see 11.3 RDA).

Do not abbreviate the name of a city or town even if it has the same name as a state, etc., listed in **table B.1** RDA (e.g., *Washington, D.C.* not *Wash., D.C.*). Do not abbreviate any place name that is not in the list.

B.4 Transcribed Elements

For transcribed elements, use only those abbreviations found in the sources of information for the element.

If supplying all or part of a transcribed element, generally do not abbreviate words.

B.5 Other Elements

B.5.1 Dimensions

Use abbreviations prescribed in B.7 RDA for terms used for dimensions (see 3.5 RDA). Metric symbols are not abbreviations; such symbols are not followed by a full stop.

B.5.2 Extent of Storage Space

Metric symbols are not abbreviations; such symbols are not followed by a full stop. Use abbreviations prescribed in B.7 RDA, as applicable, when recording extent of storage space in non-metric units of measure (see 3.4.1.11.2 RDA).

B.5.3 Duration

Use abbreviations prescribed in B.7 RDA for terms used for duration (see 7.22 RDA).

B.5.4 Numeric Designation of a Musical Work

Use abbreviations prescribed in **B.7–B.10 RDA** for terms used as part of the numeric designation of a musical work (see **6.16 RDA**).

B.5.5 Numbering of Part

Use abbreviations prescribed in B.7–B.10 RDA for terms used as part of the numbering of a part (see 24.6 RDA).

B.5.6 Medium of Performance of Musical Content

Use abbreviations prescribed in B.7 RDA for voices when recording two or more voices (e.g., "SA" for "soprano" and "alto") as medium of performance of musical content (see 7.21 RDA).

B.5.9 Date

Use the abbreviations *A.D.* and *B.C.* when recording a date in the Christian calendar associated with a person (see 9.3 RDA), family (see 10.4 RDA), corporate body (see 11.4 RDA), work (see 6.4 RDA), or expression (see 6.10 RDA).

B.5.10 Other Distinguishing Characteristic of a Legal Work

Use etc. in the term Protocols, etc. (see 6.21.1.3 RDA).

B.5.11 Other Elements

Generally do not abbreviate words in elements other than those covered under B.5.1 RDA and B.5.3–B.5.9 RDA.

Do not abbreviate words quoted in notes.

Generally do not abbreviate words recorded as part of details of an element.
