California State Library: Cooperative System Report (May 10, 2019)

California Library Literacy Services: The continuing application period for adult and family literacy funds for California Library Literacy Services (CLLS) libraries has opened; please look out for a message from Andrea Freeland on the CLLS listservs. Due May 31, 2019.

COHS. The Career Online High School Program (COHS) is accepting applications for new participating libraries and additional scholarships. Applications are due by June 10, 2019. Competitive grants. FY 2019-20 LSTA Competitive Grant applications are due by May 20, 2019. Applicants will be notified in early June.

Crisis collection. Look for an announcement soon on the Calix and directors' listservs about a crisis collection funding opportunity for California public libraries. Libraries in areas that have experienced significant impacts due to disasters in the past 18 months may apply to receive support to build library collections that will help their communities recover. Libraries may apply for one of three funding levels: \$5,000; \$8,000; and \$10,000; funding will be on a reimbursement basis.

May Revise. As you may know, the May Revise to the Governor's Budget was released on May 9, earlier than anticipated. The budget includes significant new funding for the State Library. In addition to the \$1 million for the Zip Books Project and the \$1 million for the Lunch at the Library project, which were included in the January Governor's Budget, the following are now included:

- One-Time Funding to support Early Learning and After-School Library Program Grants—\$5 million one-time General Fund to support grants for local library jurisdictions with the lowest per capita library spending to develop and implement early learning and after-school library programs.
- One-Time Funding to support Mobile Libraries—\$3 million one-time General Fund for the California State Library to support grants for local library jurisdictions to purchase bookmobiles and community outreach vehicles that would be used to expand access to books and library materials in under-resourced neighborhoods.
- Augmentation to support Digitization and Cultural Preservation Activities—\$1.7 million General Fund, approximately \$1 million of which is ongoing, for the California State Library to coordinate with state entities to identify items for digital preservation, contract for digital preservation services, and to begin conducting or commissioning a statewide survey to inventory cultural heritage assets.
- Statewide Lesbian, Gay, Bisexual, and Transgender Historical Preservation—\$500,000 one-time General Fund to support the preservation of historical Lesbian, Gay, Bisexual, and Transgender sites.

We are working to update the rest of the reports on the portal within the next few weeks. We're also working on developing a new statistics portal and offering some new statistics tools using Tableau, we'll be announcing some of these this summer.

Teen services. This spring the State Library has sponsored a series of workshops around the state on teen services competencies for library staff, developed by YALSA (http://www.ala.org/yalsa/face-face-training). Most of the workshops have already been held; the last will be on May 20 at the Whittier Public Library.

Value of Libraries. We will soon release a report on a survey conducted last fall by the Institute of Social Research at California State University, Sacramento, to measure the opinions of California residents regarding the value of public libraries. Zip Books. The State Library recently released a request for application to be the fiscal and program partner for the Zip Books program.
