Library Services and Technology Act (LSTA) Grant Opportunities:

1. **CopyCat Grants, 2020-2021**: For applicants who want to bring proven, successful programs to their communities this fiscal year

Applications are due by Monday, November 9, 2020

The CopyCat Grants program invites California public libraries to apply for funding to "copy" an effective, replicable project that can be accomplished in a nine-month period (December 2020-August 2021). These grants are intended to help libraries easily implement tried-and-tested programming and extend the impact of previously funded, successful projects. Libraries may apply to copy one of 13 innovative projects that we've identified from public libraries across California, or they may propose to receive funding to replicate a different project that fits within the guidelines. New this year are Memory Lab and NASA@ My Library toolkits. For each of the identified projects, a toolkit has been developed to help libraries apply for and implement a CopyCat grant based on that project. Programs may be adapted to accommodate restrictions imposed by the pandemic. Please see the CopyCat Grants website for more information and to apply:

Local and Collaborative competitive grants help libraries respond effectively to local needs and align services with local community aspirations, and support experimentation and R&D in California's libraries. The funding period is July 1, 2021-June 30, 2022.

JobNow and VetNow

A <u>Spanish-language version</u> of the submission form is also available.

All Californians are welcome to submit typed or handwritten journals, letters, e-mail narratives and blog posts; photographs, videos and audio; written or recorded interviews with family or friends; artwork and drawings; and other storytelling methods. Some of you have created your own COVID-19 archives, and we invite you to share submissions so we can showcase them on a statewide level. Many underserved communities throughout the state that aren't able to conduct similar collecting efforts, so please share California COVID Diaries with your communities so that we may share their experiences.
